The Function Hall Rental Fee is \$400.00 Cleaning Fee \$50.00 Optional Non-Alcoholic Beverage Service \$25.00 Optional Alcoholic Beverage Service with Bartender \$75.00 (required if alcohol is sold on premises) A deposit of \$200.00 will reserve the rental and is refundable if notice of cancellation is give within fifteen days of the rental agreement. The remainder of the balance for the rental hal required to be paid in full two weeks before the rental. Nonpayment of balance or cancellated within two weeks of the rental will result in cancellation of rental and loss of full deposit. If event is cancelled by the renter prior to two weeks before rental date, \$150.00 will be ret the renter. An additional \$50.00 security deposit is required with reservation.
